Our Reach



By executing a comprehensive and coordinated communication strategy, we aim to generate the greatest possible exposure and recognition among our target audience.

The Caribbean Investment Forum has a captive email audience of over 16,000 business professionals, and in 2022 its social media communications reached over 800,000 people globally.

In 2022, social media campaigns generated 4.3 million impressions and attracted over 31,000 unique website visitors in the month prior to the event.


