What are the key application deadlines?	Expression of Interest Deadline: March 15, 2025 Full Proposal Deadline: May 30, 2025, 4:30 pm AST
When will applicants be notified of their results?	Successful applicants will be notified by June 16, 2025.
What types of investors will participate?	The forum attracts a diverse range of investors, including: Angel Investors Private Equity Investors Venture Capitalists

What should the full application include?	 Your proposal must have: A detailed project description (objectives, strategies, and outcomes). Budget outline and three-year financial projections. Timeline with milestones and deliverables. Team profiles and an impact assessment. Feasibility study with market analysis and risk evaluation. Note: Full applications must be accompanied by all the required supporting documentation to be considered.
Will Non-Disclosure Agreements be issued?	NDAs will be issued, upon request, before submission of the full application and supporting documents.
Will a format be provided for the full application?	No. Applicants are free to utilise the template that they best believe reflects their project. Pitch decks alone will not be sufficient to evaluate the project.
