<b>Who can apply?</b>	Innovators, developers, entrepreneurs, businesses and Investment Promotion Agencies and other interested parties with projects requiring a capital investment of over US\$1 million.
<b>Can the project be implemented in a country outside the CARIFORUM member states?</b>	No.
<b>Is there a limit on the maximum investment?</b>	No, there is no limit on the desired investment size.
<b>What types of projects are eligible?</b>	<p>Projects aligned with the following sectors:</p> <p>Sustainable Agriculture: Eco-friendly practices, food security, and advanced farming solutions, etc.</p> <p>Green Economy Transition: Renewable energy, green technologies, and carbon footprint reduction, etc.</p> <p>Digitalisation of Business: Digital tools and strategies for business efficiency and growth, etc.</p>
<b>What are the key application deadlines?</b>	<p>Expression of Interest Deadline: March 15, 2025</p> <p>Full Proposal Deadline: May 30, 2025, 4:30 pm AST</p>
<b>When will applicants be notified of their results?</b>	Successful applicants will be notified by June 16, 2025.
<b>What types of investors will participate?</b>	<p>The forum attracts a diverse range of investors, including:</p> <p>Angel Investors</p> <p>Private Equity Investors</p> <p>Venture Capitalists</p>

<b>What should the full application include?</b>	<p>Your proposal must have:</p> <ol style="list-style-type: none"> <li>1. A detailed project description (objectives, strategies, and outcomes).</li> <li>2. Budget outline and three-year financial projections.</li> <li>3. Timeline with milestones and deliverables.</li> <li>4. Team profiles and an impact assessment.</li> <li>5. Feasibility study with market analysis and risk evaluation.</li> </ol> <p><b>Note: Full applications must be accompanied by all the required supporting documentation to be considered.</b></p>
<b>Will Non-Disclosure Agreements be issued?</b>	NDA's will be issued, upon request, before submission of the full application and supporting documents.
<b>Will a format be provided for the full application?</b>	No. Applicants are free to utilise the template that they best believe reflects their project. Pitch decks alone will not be sufficient to evaluate the project.
